# CMA International Joins Ministerial Roundtable Riyadh, Saudi Arabia | 14 - 16 January 2025

From 14 to 16 January, Dennis Gibson, Chairman of the Critical Minerals Association USA attended the Future Minerals Forum in Riyadh, Saudi Arabia. He joined and took part in the Future Minerals Forum's 2025 Ministerial Roundtable. Serving as the world's largest ministerial gathering of minerals and metals in the world, the Roundtable convened over 70 governments, including senior officials from Saudi Arabia, Algeria, Australia, Mexico, South Africa, Argentina, Germany, Angola, South Korea, Pakistan, and Ghana. The Roundtable also included 35 international organisations and NGOs, including the World Bank, United Nations, and CMA International.

# The EU Omnibus Regulation: Preparing for changes to European sustainability disclosure regulations

## London | 29 January 2025

The European Union is embarking on a journey to streamline and simplify its corporate sustainability rules through the proposed EU omnibus regulation. By consolidating the Corporate Sustainability Reporting Directive (CSRD), the Corporate Sustainability Due Diligence Directive (CSDDD), and the EU Taxonomy, the EU aims to reduce compliance burdens while addressing concerns over Europe's economic competitiveness and regulatory complexity.

#### What is the EU omnibus?

In November 2024, the President of the European Commission Ursula von der Leyen indicated that the European Union (EU) was considering consolidating the CSRD, CSDDD, and EU Taxonomy into one omnibus to reduce the regulatory burden for companies.

This announcement followed growing concerns over the complexity of the three rules and the time and resources it would take for companies to comply with them. In September 2024, former Italian Prime Minister Mario Draghi <u>released</u> The future of European competitiveness – A competitiveness strategy for Europe, a report which highlighted regulatory barriers as a primary reason for the EU's stagnant economy.


